We may revise these Terms from time to time. Any changes will be posted on this page, and the revised Terms will be effective upon posting. It is your responsibility to review these Terms regularly. Continued use of the Platform after any changes constitutes your acceptance of the revised Terms.

2. SUBSCRIPTIONS AND EVENT ACCESS

2.1 Subscription Plans

Indistrict offers various subscription plans that grant users access to our exclusive event listings, digital passes, and partner promotions. Subscription fees are billed on a recurring basis (e.g., monthly or annually) based on your chosen plan.

2.2 Event Access and Passes

As a Subscriber, you will receive access to certain partner events, including free entry before 2:00 AM, as well as other event-related benefits. Event details, such as location, date, and time, will be available on the Platform.

2.3 Entry Conditions

- Free entry is valid only for the times specified on the event listing (usually until 2:00 AM) and may be subject to availability.
